

PRIVACY POLICY

Who are we?

Regal Amusement Machine Sales Ltd (trade name Regal Gaming Technologies, Reg. Company No: 03329800) registered in England & Wales and whose registered office is at Brookfield Place, Preston, PR5 8BF are committed to protecting your privacy and keeping any personal data you provide to us confidential at all times, in accordance with UK data protection laws. This Privacy Notice sets out the information processing activities that Regal Gaming Technologies carries out in its capacity as data controller.

All personal data collected by Regal Gaming Technologies is processed in compliance with the requirements of the UK General Data Protection Regulation, the UK Data Protection Act 2018 and any other relevant legislation.

How is your information collected?

Personal data is any information about an individual from which that person can be identified. The personal information that we may collect about you broadly falls into the following categories:

Information that you provide voluntarily

We may process and store information that you have provided voluntarily. For example, when you provide your details on our "contact us" form. It will be clear to you at this point what personal data you are providing.

<u>Information that we obtain from third party sources</u>

From time to time, we may obtain personal information about you from third party, but only where we have checked that these third parties either have your consent or are otherwise legally permitted or required to disclose your personal information to us.

Information that we collect from your activities

We collect information about how you use our website automatically through the use of cookies and other technologies. Some of these cookies can be enabled/disabled by selecting your preferences in the preference centre you are presented with when first interacting with this site. More information on cookies can be found under the 'Use of cookies' section below.

How is your information used?

We will only process (use) your personal information where:

- we need to comply with a legal obligation;
- we have a 'legitimate interest' to do so in order to support our company aims. Our use will be fair and balanced and never unduly impact on your rights;



- we have a contract with you that we can only fulfil by using your personal information
- we have asked your consent for us to do so.

Special categories of personal data

"Special categories" of personal data require higher levels of protection. We need to have further justification for collecting, storing and using this type of personal information. In instances where we process special category data, we will only do so prior to your explicit consent.

Less commonly, we may process this type of information where it is needed in relation to legal claims or where you have already made the information public.

We may collect, store and use the following "special categories" of personal data:

For some of your personal information you will have a legal, contractual, or other, requirement or obligation to provide us with your personal information. Email and text

Service communications

We may send you certain communications, without your consent, if we are under a legal obligation to do so; if we feel sending the communication is in both yours and our interests; and/or it would be a disadvantage to you if we didn't send you the communication.

These communications may include:

- Asking you to provide feedback on our products, services and events

Your rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the right to object to the processing of your personal information in certain circumstances.



Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

Your right to withdraw consent - If the lawful basis for processing is consent, you have the right to withdraw that consent at any time. Please note however that the withdrawal of your consent will not affect any use of the data made before you withdrew your consent, and we may still be entitled to hold and process the relevant personal information to the extent that we are entitled to do so on bases other than your consent. Withdrawing consent may also have the same effects as not providing the information in the first place, for example we may no longer be able to provide certain services to you.

Your right to object to direct marketing - Where your personal data are processed for direct marketing purposes, you have the right to object at any time to processing of your personal data for marketing, which includes profiling to the extent that it is related to such direct marketing.

Automated decision making

Your also have the right to object to and not to be subject to a decision based solely on automated processing including profiling. We do not carry out automated processing or profiling.
